

SNAP THE MARATHON - COMPETITION RULES

- 1. These rules set the conditions and rules for the SNAP THE MARATHON 2018! competition.
- 2. The competition is organized by the company Progress Promotion Košice, s.r.o. (hereinafter only the "organizer") in cooperation with the company FaxCopy Pro, which is the co-organizer.
- 3. The competition runs within the Slovak Republic from 7 October 2018 to 31 October 2018.
- 4. The deadline for registration and submitting photographs to the competition is set from **7 October 2018 to midnight on 13 October 2018**.
- 5. Any citizen of Slovakia, who on the day of entering the competition is at least 15 years old and meets the requirements set by these rules, may participate, according to which he or she sends together with a properly filled in registration form at least one and at most three photographs to which he or she has unlimited authorial rights and of which he or she is also the author to the SNAP THE MARATHON! photography competition.
- 6. Employees and collaborators of Progress Promotion Košice, s.r.o., FaxCopy Pro and the organizers of the Košice Peace Marathon and members of the jury may not take part in the competition.
- 7. Users may enter photographs into the competition through registration on the Web page at www.kosicemarathon.com. By providing one's own data a competitor tacitly consents with the data being processed by the competition organizer for the purposes of internal use.
- 8. Authors send photographs to the competition in the form of a .jpeg, or .tiff file in a maximum resolution with a size up to 50MB. Competition finalists may be asked to supply the original source photography in a larger data volume (and resolution) for possible case of further use in the scope of the SNAP THE MARATHON! project.
- 9. Contributions that do not satisfy the requirements set in point 8 will not be included in the competition.
- 10. The organizer reserves the right to reject from the competition any contribution whose contents may cause offense, offend a race of people or religious or political beliefs, and contributions which are not in conformity with the valid laws and also photographs which show signs of being an advert or a hidden advert.
- 11. All photographs submitted in line with these rules will be published on the Web page www.faxcopypro.sk.
- 12. Contributions submitted will be assessed, evaluated and awarded by the jury by **31 October 2018**. The professional jury will select the final ten photographs and the winning authors of the photographs in this order: 1st place, 2nd place, 3rd place.
- 13. The authors of the winning photographs will get a material prize from the company Canon Slovakia specified in the public competition campaign.
- 14. The jury reserves the right to not award any prize.
- 15. Decisions of the jury related to the awarding or not awarding prizes is final.
- 16. The names of the winners and finalists will be published on the Web page at www.kosicemarathon.com and the Web page of the co-organizer of the competition at www.faxcopypro.sk, or in other media outputs.
- 17. The names and order of the winners will be published on the Web page at www.kosicemarathon.com and the Web page of the competition co-organizer at www.faxcopypro.sk no later than by 31 October 2018.
- 18. Selected submissions will be exhibited by the organizer of the contest, stating the name and surname of the author and ensuring the protection of the copyright to the work, in particular the non-infringement of the copyright and the right to inviolability of the work.
- 19. The organizer owns the copyright for the contributions sent to this competition to the extent that it allows them to display and publish these contributions in order to promote the SNAP THE MARATHON! competition and the Košice Peace Marathon, with the right especially of publishing these contributions on the www.kosicemarathon.com website, the coorganizer's website, in the scope of the project, and further in the media promotion of the Košice Peace Marathon. By sending photos to the SNAP THE MARATHON! the contributor agrees to the use of his or her photograph (or cut from a photo) free of charge on the portals of the organizer, in the areas of use specified in the call for submissions and in the rules of photo competition and for use on promotional materials, including other media.
- 20. Award-winning competitors will be notified by the organizer of the outcome of the evaluation by telephone and/or e-mail as stated in the registration form.
- 21. The organizer hereby declares that it accepts the contestant's declaration contained in the competition registration form and that free of charge it assumes the copyright of the submitted contributions in the areas of use mentioned in the call for submissions and in the rules of the photo competition.
- 22. The organizer assumes no responsibility for damages arising to third parties caused by violation of these rules by contestants (for example, registration of a contribution to which the competitor does not own copyrights, etc.).
